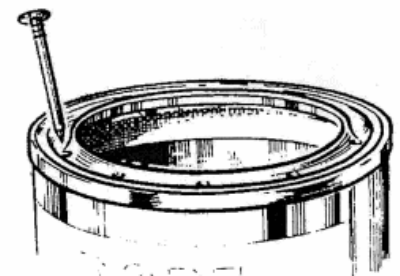
Trez/Ed Sez – *By Le Roy Stuczynski*
