Show and tell: Le Roy showed a computer slideshow of AirVenture 2009. The show precipitated an interesting discussion.



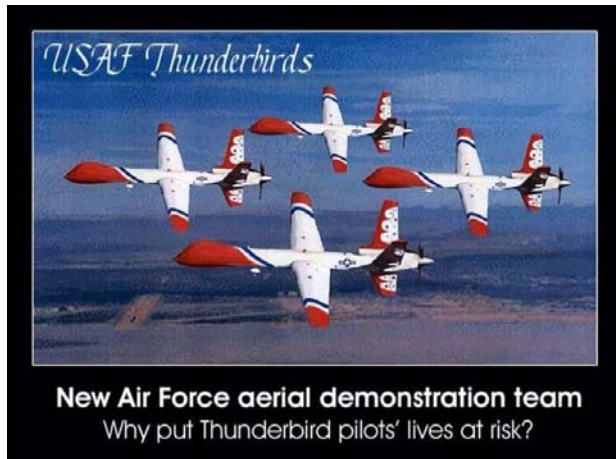
